19 WHEREAS, this Court entered an order (ECF No. 8) permitting Plaintiff to conduct early
20 discovery and serve subpoenas on nonparty internet service providers to obtain the identities and
21 contact information of the defendants Does 1-178;

22 WHEREAS, Doe 129 was unable to obtain counsel to represent her in this action until
23 today and has requested additional time to file a motion to quash or otherwise respond to the
24 subpoena served on Comcast Corporation seeking disclosure of her personal information;

25 NOW THEREFORE, the parties, through their counsel, hereby stipulate as follows:

- 26 1. Doe 129 shall have until November 1, 2012 to move to quash or otherwise
27 respond to the subpoena to Comcast Corporation.

1 2. Comcast Corporation shall not disclose the information belonging to Doe 129
2 until further order of the Court or until November 2, 2012 if no response to the subpoena has
3 been filed by Doe 129 before that time.

4 3. If the information belonging to Doe 129 is inadvertently disclosed to Plaintiff or
5 to Plaintiff's counsel by Comcast Corporation, that information may not be used in this action for
6 any purpose unless and until it is disclosed in a manner that does not violate this stipulation and
7 order.
