1 Plaintiff, by and through his attorney-of-record, and Defendants, by and  
2 through their attorneys-of-record, hereby stipulate to the following:

3  
4 1. Plaintiff filed this action on or about July 24, 2012, seeking to compel  
5 Defendants to adjudicate his pending adjustment of status application. Defendants  
6 received a 60-day extension of their filing deadline to respond to the complaint,  
7  
8 which is currently due by March 12, 2013.

9 2. Defendants removed Plaintiff's application from its prior adjudicatory  
10 hold, completed the adjudication of the application, and granted Plaintiff  
11 permanent residence on February 28, 2013.

13 3. Pursuant to Rule 41(a)(1)(ii) of the Federal Rules of Civil Procedure, the  
14 parties stipulate to the dismissal, with prejudice, of the entire action. Each party is  
15 to bear its own costs and fees, and no attorney's fees or costs under the Equal  
16 Access to Justice Act, or any other provision of law, will be sought in the above-
