Re: Dkt. Nos. 35, 41

16 Having considered the Joint Stipulation to Continue Dates and Deadlines
17 submitted by the parties, Dkt. No. 41, and good cause appearing, the Court amends the
18 previous Case Management Order dated February 22, 2013, Dkt. No. 35, as follows:

19 1. MEDIATION. The parties must complete private mediation by April 18, 2014.
20 2. DISCOVERY. The parties must complete all non-expert discovery by June 18,
21 2014.

22 3. EXPERT WITNESSES. The disclosure and discovery of expert witness
23 opinions will proceed as follows:

24 (A) By March 4, 2014, plaintiff must disclose expert testimony and reports
25 in accordance with Federal Rule of Civil Procedure 26(a)(2).

26 (B) By March 18, 2014, defendant must disclose expert testimony and
27 reports in accordance with Federal Rule of Civil Procedure 26(a)(2).

1 (C) The parties must make any supplemental expert disclosures by April 30,
2 2014 and complete all discovery of expert witnesses by June 30, 2014.

3 4. DISPOSITIVE MOTIONS. Dispositive motions must be filed by June 30,
4 2014.

5 5. PRETRIAL CONFERENCE. The final pretrial conference will be held on
6 September 17, 2014 at 2:00 p.m. in Courtroom A, 15th Floor, U.S. District Court, 450
7 Golden Gate Avenue, San Francisco, California. Lead counsel must attend the
8 conference.

9 6. TRIAL DATE. Trial will be held on October 27, 2014 at 9:00 a.m. in
10 Courtroom A, 15th Floor, U.S. District Court, 450 Golden Gate Avenue, San Francisco,
11 California.

12 7. FURTHER CASE MANAGEMENT CONFERENCE. A further case
13 management conference is scheduled for 10:00 a.m. on May 7, 2014 in Courtroom A,
14 15th Floor, U.S. District Court, 450 Golden Gate Avenue, San Francisco. The parties
15 must file a joint case management conference statement by April 30, 2014.
