3 After considering the stipulation, and for good cause shown:

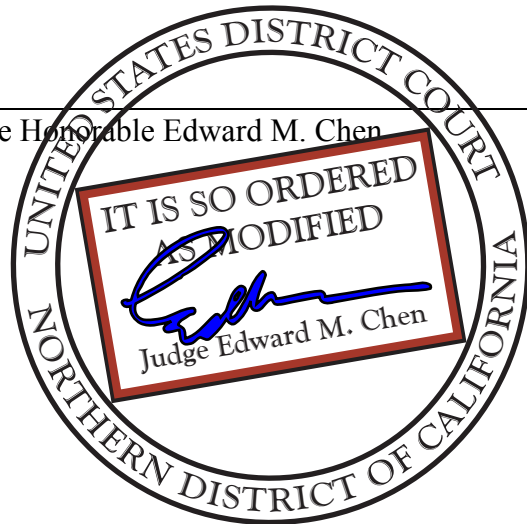
4 **IT IS HEREBY ORDERED THAT:**
