 23 DOLLARS AND 00/CENTS (\$7,500.00), and costs in the amount of THREE HUNDRED FIFTY
 24 DOLLARS AND 00/CENTS (\$350.00). This amount represents compensation for all legal services
 25 rendered on behalf of Plaintiff by counsel in connection with this civil action, in accordance with 28
 26 U.S.C. § 2412(d).

1 This stipulation constitutes a compromise settlement of Plaintiff's request for EAJA attorney
2 fees, and does not constitute an admission of liability on the part of Defendant under the EAJA. Payment
3 of SEVEN THOUSAND FIVE HUNDRED DOLLARS AND 00/CENTS (\$7,500.00), and costs in the
4 amount of THREE HUNDRED FIFTY DOLLARS AND 00/CENTS (\$350.00), shall constitute a
5 complete release from and bar to any and all claims Plaintiff may have relating to EAJA fees in
6 connection with this action. Any payment shall be delivered to Plaintiff's counsel.
