25 WHEREAS, Plaintiff Jeff Stivers ("Plaintiff") and Defendant RadioShack Corporation
26 ("Defendant") (collectively, Plaintiff and Defendant are referred to as the "Parties") want to
27 make best efforts to settle this case without further litigation and keep all fees and costs to a
28 minimum until all settlement efforts have been exhausted;
