17 The undersigned parties, through their respective counsel, hereby stipulate as follows:

18 (1) In the Stipulation And Order To Vacate Default (filed March 1, 2013), the parties
 19 agreed that plaintiffs' request for default judgment against American Home and National Union
 20 may and should be vacated by the Court, and that American Home and National Union shall have
 21 21 days from the date of the Order on that stipulation within which to respond to plaintiffs'
 22 complaint. That Order was entered on March 4, 2013.

23 (2) Under the Stipulation And Order To Vacate Default, defendants American Home
 24 and National Union's response to plaintiffs' complaint was due on or before March 25, 2013.


25 (3) By subsequent stipulations, the parties agreed that defendants American Home and
 26 National Union shall respond to plaintiffs' complaint on or before May 6, 2013.

27 (4) In order to conserve the parties' resources and potentially to avoid additional
 28 burdens on the Court, the parties hereby agree to extend the May 6, 2013 deadline another two


1 weeks, to and including May 20, 2013.

2 (5) Pursuant to the Clerk's Notice Rescheduling Hearing, entered on April 30, 2013,
3 the Case Management Conference previously set for May 24, 2013 has been rescheduled for May
4 31, 2013.

5 (6) Counsel for plaintiff has a trial scheduled in another case on May 31, 2013, which
6 conflicts with the rescheduled Case Management Conference. As such, the parties hereby
7 stipulate and agree that the Case Management Conference in this matter should be continued until
8 June ¹⁴ 7, 2013 or such other date as is convenient for the Court.
