1 Plaintiff Robert Santiago (“Plaintiff”) and Defendant ARAMARK Uniform & Career
2 Apparel, LLC (“Defendant” or “AUCA”), by and through their respective undersigned counsel,
3 hereby stipulate and agree as follows:

- 4 1. On December 21, 2012, Defendant filed a Motion for Judgment on the Pleadings
5 and Motion to Dismiss pursuant to Rules 12(c) and 12(h)(3). Defendant’s motion
6 is scheduled to be heard by the Court on February 8, 2013.
- 7 2. In light of holiday schedules and attorney absences, the parties have agreed to give
