ORDER

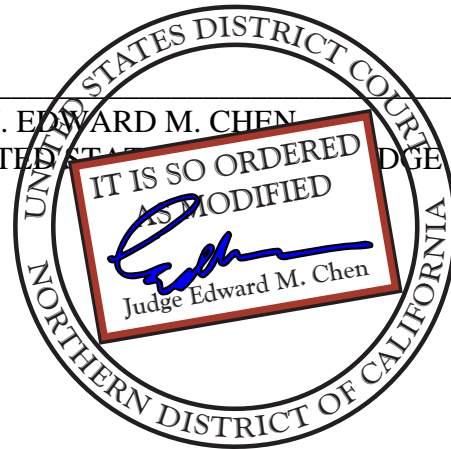
The Court, having considered the stipulation of the parties, orders as follows:
