 20 finds as follows:

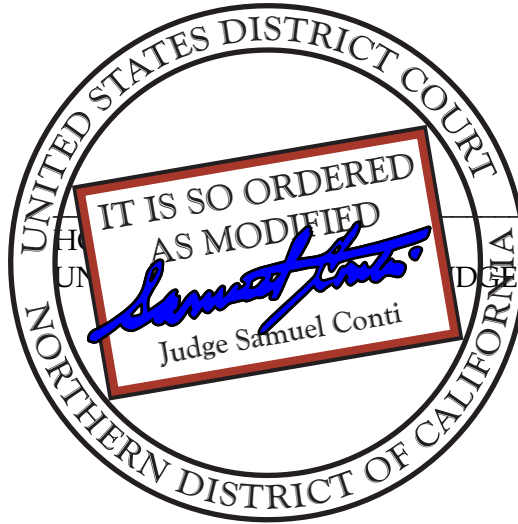
22 The stipulation to continue the hearing currently set for May 31, 2013 until July 12, 2013, and to
