25 Accordingly, the parties request that the January 7, 2013 order referring the parties to
 26 mediation and the notification from this Court's ADR Unit confirming the appointment of
 27 Gregory D. Walker, Esq. to mediate the matter be rescinded.

1 IT IS FURTHER STIPULATED and requested that the Settlement Conference now set
