20 WHEREAS, a Complaint in admiralty was filed herein praying that process be issued for

22 NOW THEREFORE you are commanded to arrest said Defendant vessel, with her sails,

1 them to the person(s) in possession of the Sailing Vessel Energy Team AC45; and 2) give due
2 notice to all persons and entities having an interest in the property under seizure by publication in
3 a newspaper of general circulation in the judicial district where the Defendant vessel was seized.

4 You are commanded to arrest the Sailing Vessel Energy Team AC45 and prevent it from
5 leaving the district until notice is provided by plaintiff or the Court that adequate substitute
6 security has been provided.

7 You are hereby authorized to move the Sailing Vessel Energy Team AC45 at the
8 discretion or direction of the harbor master or the United States Coast Guard. You shall afford
9 the sailing vessel Energy Team AC45's crew and other third parties the opportunity to retrieve
10 any personal property from the vessel.
