1 WHEREAS, on July 30, 2013, the Court entered an Order denying Plaintiffs' Motion For  
2 Leave To File A Motion For Reconsideration and granting Plaintiffs 20 days to file a Second  
3 Amended Complaint;

4 WHEREAS, under the terms of the Court's Order, Plaintiffs' Second Amended  
5 Complaint is currently due to be filed on or before August 19, 2013;

6 WHEREAS, the filing of the Second Amended Complaint is to be done Under Seal, as it  
7 involves citations to and exhibits of material that Defendant Gogo Inc. has designated as "Highly  
8 Confidential" under the terms of the Stipulated Protective Order previously entered by the Court;

9 WHEREAS, as a result of the need to file the Second Amended Complaint under seal,  
10 Plaintiffs' counsel will be unable to file the pleading electronically through the Court's  
11 Electronic Case Filing system but, instead, will have to file it in paper form through the Office of  
12 the Clerk of the Court following the requirements of Civil Local Rule 79-5;

13 WHEREAS, lead counsel for Plaintiffs, Roy A. Katriel, is currently out of the country  
14 and will not return back to the United States until the evening of August 21, 2013;

15 WHEREAS, lead counsel for Plaintiffs, Roy A. Katriel, has also been informed that his  
16 co-counsel, Azra Mehdi, who is officed in San Francisco and hence serving as local counsel for  
17 Plaintiffs, will also be out of town on August 19, 2013, and therefore will be unable to assist in  
18 the filing of the Second Amended Complaint on that date;

19 WHEREAS, on January 18, 2013 (Dkt. No. 24), the Court Ordered the parties to attend  
20 private mediation within 120 days following the Court's ruling on Defendant's then-pending  
21 motion to dismiss the First Amended Complaint;

22 WHEREAS, the parties have met and conferred and have agreed to mediate before  
23 Retired Magistrate Judge Edward Infante, and are coordinating available dates in October 2013  
24 for a mediation session;

25 WHEREAS, Plaintiffs would still like to file their Second Amended Complaint before  
26 attending the mediation, and both parties have an interest in conserving judicial resources and the  
27 parties' expenses pending the mediation;

1 The parties to the above-entitled action, by and through their undersigned counsel, therefore  
2 hereby Stipulate and agree, subject to Court approval, that:

- 4 1. Plaintiffs' deadline to file their Second Amended Complaint shall be extended by ten  
5 days up to and including August 30, 2013.
  - 6 2. Following the filing of Plaintiffs' Second Amended Complaint, all further  
7 proceedings in this action shall and will be stayed pending the mediation.
  - 8 3. In the event that mediation shall not resolve this action, Defendant shall respond to  
9 the Second Amended Complaint within 30 days following the conclusion of the  
10 mediation session.
  - 11 4. Within 10 days following the conclusion of the mediation session, the parties shall  
12 file a Joint Status Report to inform the Court as to the outcome of the mediation  
13 session.


