3 time and expense will be incurred for counsel's personal appearance.

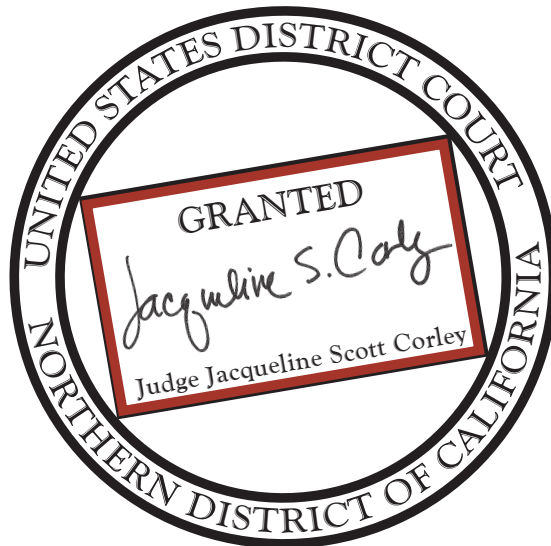
