22 Pursuant to the stipulation of the parties dated January 24, 2013, and good cause  
 23 appearing, the Court hereby orders as follows:

- 25 1. On January 14, 2013, Plaintiff filed a Motion for Intervention as Plaintiff (the
  - 26 "Intervention Motion") in *Janney et al. v. General Mills et al.*, Case No. C12-3919
  - 27 PJH, currently pending in this District.
  - 28 2. If the Intervention Motion is granted, Plaintiff shall dismiss his complaint without

1 prejudice within 14 days after the Court grants the Intervention Motion.

2 3. If the Intervention Motion is denied, the Court sets the following briefing schedule  
3 for General Mills to answer or otherwise respond to Plaintiff's Complaint.

4 a. General Mills shall answer or otherwise respond to Plaintiff's Complaint no  
5 later than 14 days after the Court denies the Intervention Motion.

6 b. To the extent that General Mills responds to Plaintiff's Complaint via motion  
7 to dismiss, Plaintiff's opposition to such motion shall be filed no later than 28  
8 days after the motion to dismiss is filed.

9 c. Any reply in support of the motion shall be filed by General Mills no later than  
10 14 days after Plaintiff files his opposition.

11 d. The Case Management Conference shall be scheduled after the Court rules on  
12 any motion to dismiss filed by General Mills.
