32 This case was filed in Northern District of California on October 19, 2012 and was
33 assigned to Magistrate Judge ~~William Alsup~~ Nathanael Cousins.

34 This is a Transvaginal Mesh Case and it is one of thousands filed in Federal Courts across
35 the country. There are current Multidistrict litigations involving both Defendants (MDL 2187, *In*
36 *re C.R. Bard, Pelvic Repair System Products Liability Litigation* and MDL 2387, *In re*
37 *Coloplast, Pelvic Repair System Products Liability Litigation*) pending before Judge Joseph R.
38 Goodwin in the Southern District of West Virginia.

1 To date Defendants C.R. BARD, INC. and COLOPLAST, INC. have not been served and
2 they have not appeared. Therefore, the parties are unable to file a Joint Case Management
3 Conference Statement. The expectation is that this case will be transferred to either of the two
4 MDLs. Plaintiffs are currently waiting for a Conditional Transfer Order.
