13 Rules of Civil Procedure to Dismiss The Cross-Claim Filed by Leslie Roman and Donna Roman

18 1. The March 14, 2013 Cross-Claim filed by Leslie Roman, Donna Roman and
19 Flexopack is hereby dismissed with prejudice as to Mario Ramirez and MCR Innovations and
20 Packaging, Inc., only.

21 2. The March 29, 2013 Cross-Claim filed by Mario Ramirez, Camilo Ramirez, MCR
22 Innovations and Packaging, Inc., MCR Printing & Packaging Corp., and Naftuaunited.com, is
23 hereby dismissed with prejudice as to Leslie Roman, Donna Roman, and Flexopack, only.
