I, JACK ROE, declare and state:

1. I am in a Plaintiff in this action. The information in this declaration is based upon my personal knowledge and if called upon to testify, I could and would competently testify thereto.

2. I previously provided the Court with a declaration, signed in California on November 2, 2012, providing my true name and the reasons I am asking to proceed as “Jack Roe” in this litigation.

3. I was born in California, and other than two years when my family lived in Nevada, I have otherwise spent the entirety of my life living in California.

4. As I indicated in my original declaration, I was so afraid of being arrested for failing to comply with Proposition 35, and so afraid it would have an adverse effect on my business, I contemplated moving out of the state so I would not have to turn over my online identification information.

5. I have now followed through with this plan. I am currently living outside of California; before I left I informed the agency with which I registered that I would be leaving their jurisdiction, as required under California law.

6. If I am not required to provide this online identifier information, or if Proposition 35 is found to be unconstitutional, I would happily move back to California, and resume my life in in the county where I previously resided.

I declare under penalty of perjury under the laws of the United States of America that the foregoing is true and correct.
