1 **STIPULATION**

2 Plaintiffs Nen Thio, Tju Tjin Liem and Denny Wijaya (“Plaintiffs”) and Defendants Genji LLC,  
3 Genji Retail Support, Inc. and Genji, Inc. (“Defendants”) (collectively “the Parties”), stipulate and agree  
4 as follows:

5 **WHEREAS**, on July 10, 2013, the Parties had a full day mediation session with Jeffrey Ross at  
6 his mediation offices in Oakland, California, at which the Parties were able to enter into a settlement of  
7 the entire case;

21 hearing on October 2, 2013, or as soon thereafter as is convenient for the Court.
