**ORDER GRANTING EX PARTE
APPLICATIONS FOR LEAVE TO
TAKE EARLY DISCOVERY**

13 Plaintiff Axel Braun (“Plaintiff”) brings these four related cases accusing Doe Defendants¹ of
14 using BitTorrent technology to illegally download copyrighted files from the Internet. Plaintiff has
15 filed Ex Parte Applications in each of the cases pursuant to Federal Rule of Civil Procedure (“Rule”)
16 26, requesting leave to take expedited discovery to determine the identity of Defendants
17 (“Defendants”) named in these action.² For the reasons explained below, the Court **GRANTS**
18 Plaintiff’s Application.

19 **BACKGROUND**

20 Braun is an individual doing business as Axel Braun Productions, with his principal place of
21 business located in Porter Ranch, California. Compl. ¶ 9, Dkt. No. 1. Axel Braun Productions
22 directs, markets, and distributes adult entertainment products, including Internet website content,
23 videos, DVDs, and photographs. *Id.* ¶ 10. Plaintiff is the co-producer and co-claimant of the

1 copyrights in the motion picture, *Star Wars XXX: A Porn Parody*.³ *Id.* ¶ 32. Plaintiff registered the
2 copyright for *Star Wars XXX: A Porn Parody* with the United States Copyright Office, and the
3 Copyright Office assigned the work the registration number PA 1-787-699. *Id.*

4 Plaintiff alleges that Defendants used BitTorrent, an internet peer-to-peer (“P2P”) file
5 sharing network, to illegally reproduce and distribute *Star Wars XXX: A Porn Parody* in violation of
6 the Copyright Act, 17 U.S.C. § 101 et seq. *Id.* ¶¶ 17-28, 33-35. Plaintiff further alleges that by
7 using the BitTorrent program to download and distribute Plaintiff’s content, each Defendant is liable
8 for contributory infringement. *Id.* ¶¶ 37-45. Because the alleged infringement occurred on the
9 Internet, Plaintiff states that Defendants acted under the guise of their Internet Protocol (“IP”)
10 addresses rather than their real names. Strassmeir Decl. ¶ 18, Dkt. No. 6-1. As a result, Plaintiff
11 contends that it cannot determine Defendants’ true identities without procuring the information from
12 Defendants’ respective Internet Service Providers (“ISPs”), which can link the IP addresses to a real
13 individual or entity. *Id.* ¶ 24. Consequently, Plaintiff asks the Court to grant expedited discovery to
14 issue subpoenas to the relevant ISPs so that the ISPs will produce identifying information for each
15 Defendant.

16 DISCUSSION

17 Rule 26(d)(1) prohibits discovery without a court order prior to a Rule 26(f) conference
18 between the parties. Courts generally use a “good cause” standard to decide whether to permit such
19 early discovery. *Semitoool, Inc. v. Tokyo Electron Am., Inc.*, 208 F.R.D. 273, 276 (N.D. Cal. 2002).
20 “Good cause may be found where the need for expedited discovery, in consideration of the
21 administration of justice, outweighs the prejudice of the responding party.” *Id.* at 276. To
22 determine whether there is “good cause” to permit expedited discovery to identify anonymous
23 internet user doe defendants, courts consider whether:

1 (1) the plaintiff can identify the missing party with sufficient specificity such that the
2 Court can determine that defendant is a real person or entity who could be sued in
3 federal court; (2) the plaintiff has identified all previous steps taken to locate the
4 elusive defendant; (3) the plaintiff's suit against defendant could withstand a motion
of being able to identify the defendant through discovery such that service of process
would be possible.

5 *OpenMind Solutions, Inc. v. Does 1-39*, No. 11-3311, 2011 WL 4715200, at *2 (N.D. Cal. Oct.7,
6 2011) (citing *Columbia Ins. Co. v. seescandy.com*, 185 F.R.D. 573, 578-80 (N.D. Cal. 1999)). The
7 Court will consider each of these factors in turn.

8 **A. Identification of Defendants as Persons Who Can Be Sued**

9 Under the first factor, the Court must examine whether Plaintiff has identified the Defendants
10 with sufficient specificity, demonstrating that each Defendant is a real person or entity who would
11 be subject to jurisdiction in this Court. *Columbia Ins. Co.*, 185 F.R.D. at 578. Plaintiff proffers that
12 he retained Media Protector International GmbH ("MPI"), which utilized forensic software to
13 identify Defendants' IP addresses on the date and time that they engaged in the alleged distribution
14 of *Star Wars XXX: A Porn Parody* via the BitTorrent protocol, and has compiled the information
15 into a log attached as Exhibit A to Plaintiff's Complaint. Strassmeir Decl. ¶¶ 2, 11-18, Ex. A.
16 Plaintiff explains that each time the subscriber accesses the Internet, the ISP provides a unique IP
17 address that is somewhat akin to a telephone number, and that ISPs record in user logs the times and
18 dates it assigns each IP address to a subscriber. *Id.* ¶ 20. The IP addresses MPI identified enable it
19 to determine which ISP each peer used to gain access to the Internet. *Id.* ¶ 22. MPI can then search
20 public databases to determine which Internet access provider controls a specific IP address. *Id.*
21 Plaintiff can then use this information to obtain Defendants' names, addresses, e-mail addresses, and
22 other identifying information. *Id.* ¶ 18. Thus, the Court finds that Plaintiff has come forward with
23 sufficient information demonstrating that the Defendants are real persons or entities who may be
24 sued in federal court. *See MCGIP, LLC v. Does 1-149*, 2011 WL 3607666, at *2 (N.D. Cal. Aug.
25 15, 2011) (finding that the plaintiff had identified the doe defendants with sufficient specificity by
26 submitting a chart listing each of the defendants by the IP address assigned to them on the day it
27 alleged the particular defendant engaged in the infringing conduct).

1 **B. Previous Steps Taken to Identify the Doe Defendants**

2 Under the second factor, the Court must assess the prior steps Plaintiff has taken to locate the
3 Defendants. *Columbia Ins. Co.*, 185 F.R.D. at 579. “This element is aimed at ensuring that
4 plaintiffs make a good faith effort to comply with the requirements of service of process and
5 specifically identifying defendants.” *Id.* Having reviewed Mr. Strassmeir’s testimony, the Court is
6 satisfied that Plaintiff has sufficiently described its efforts to identify Defendants. Mr. Strassmeir
7 states that once MPI identified a peer distributing *Star Wars XXX: A Porn Parody*, it obtained and
8 recorded publically available information about the peer, including the time and date at which the
9 peer distributed the file, the IP address the peer used to access the Internet, and the infohash (a
10 unique identifier created for each file by the BitTorrent protocol). Strassmeir Decl. ¶ 15. Mr.
11 Strassmeir states that, because of the partially anonymous nature of the P2P Internet distribution
12 system used by Defendants, MPI is unable to determine their true names, street addresses, telephone
13 numbers, and email addresses. *Id.* ¶ 18.

14 **C. Withstanding a Motion to Dismiss**

15 Under the third factor, the inquiry shifts to the substance of Plaintiff’s claims and analyzes
16 whether Plaintiff’s Complaint would likely survive a motion to dismiss. *Columbia Ins. Co.*, 185
17 F.R.D. at 579. In its Complaint, Plaintiff has asserted a federal copyright infringement claim. To
18 state a claim for copyright infringement, Plaintiff must establish: (1) ownership of a valid copyright,
19 and (2) copying of constituent elements of the copyrighted work that are original. *Rice v. Fox*
20 *Broad. Corp.*, 330 F.3d 1170, 1174 (9th Cir. 2003) (citing *Feist Publ’n, Inc. v. Rural Tel. Serv. Co.*,
21 499 U.S. 340, 361 (1991)). “To be liable for direct infringement, one must ‘actively engage in’ and
22 ‘directly cause’ the copying.” *Online Policy Group v. Diebold, Inc.*, 337 F. Supp. 2d 1195, 1199
23 (N.D. Cal. 2004).

24 Reviewing Plaintiff’s Complaint, Plaintiff has adequately alleged that *Star Wars XXX: A*
25 *Porn Parody* is the subject of a valid Certificate of Registration issued by the United States
26 Copyright Office and that Plaintiff is the co-claimant in the copyrights for the movie. Compl. ¶ 2.
27 Plaintiff has also alleged that the Defendants reproduced and distributed *Star Wars XXX: A Porn*

1 *Parody* via BitTorrent to numerous third parties. Compl. ¶¶ 33-34. Additionally, Plaintiff has
2 alleged that Defendants actively engaged in or directly caused the copying by completing each of the
3 steps in the BitTorrent file-sharing protocol, including intentionally downloading a torrent file
4 particular to *Star Wars XXX: A Porn Parody* , loading that torrent file into the BitTorrent client,
5 entering a BitTorrent swarm particular to *Star Wars XXX: A Porn Parody* , and ultimately,
6 downloading and uploading pieces of a *Star Wars XXX: A Porn Parody* file to eventually obtain a
7 whole copy of the file. *Id.* ¶¶ 18-29. Based on these allegations, the Court finds that Plaintiff has
8 pled a prima facie case of copyright infringement.

9 Plaintiff has also made a prima facie showing that the Complaint would withstand a motion
10 to dismiss for lack of personal jurisdiction. The Complaint alleges that the ISP associated with each
11 Doe Defendant is located in California; thus, the allegations of the Complaint support an inference
12 that all of the Doe Defendants reside in California. *Id.* ¶ 6. At this stage in the proceedings, this is
13 a sufficient showing. Accordingly, Plaintiff has set forth sufficient supporting facts to survive a
14 motion to dismiss.

15 **D. Whether there is a Reasonable Likelihood of Being Able to Identify Defendants**

16 The fourth factor examines whether Plaintiff has demonstrated that there is a reasonable
17 likelihood that the discovery he requests will lead to the identification of Defendants such that it
18 may effect service of process. *Columbia Ins.*, 185 F.R.D. at 580. As indicated above, Plaintiff
19 contends that the key to locating the Defendants is through the IP addresses associated with the
20 alleged activity on BitTorrent. Specifically, Plaintiff contends that because ISPs assign a unique IP
21 address to each subscriber and retain subscriber activity records regarding the IP addresses assigned,
22 the information sought in the subpoena will enable Plaintiff to serve Defendants and proceed with
23 this case. Pl.'s App. at 5; Strassmeir Decl. ¶¶ 19-23. Taking this into account, the Court finds that
24 Plaintiff has made a sufficient showing as to this factor.

25 **E. Summary**

26 Taking the above factors into consideration, the Court finds that Plaintiff has demonstrated
27 that good cause exists to grant leave to conduct early discovery. Moreover, the Court finds that the
28

1 expedited discovery sought furthers the interests of justice and presents minimal inconvenience to
2 the ISPs to which the subpoenas are directed. Thus, the expedited discovery is in line with Rule
3 26(d).

4 **F. Joinder of Doe Defendants**

5 Having found that expedited discovery is appropriate, the question becomes whether the
6 discovery sought is proper as to all Doe Defendants. Under Rule 20, defendants may be joined in
7 one action when claims arise from the same transaction or occurrence or series of transactions or
8 occurrences, and any question of law or fact in the action is common to all defendants. Fed. R. Civ.
9 P. 20(a)(2). The permissive joinder rule “is to be construed liberally in order to promote trial
10 convenience and to expedite the final determination of disputes, thereby preventing multiple
11 lawsuits.” *League to Save Lake Tahoe v. Tahoe Reg’l Planning Agency*, 558 F.2d 914, 917 (9th Cir.
12 1997). The purpose of Rule 20(a) is to address the “broadest possible scope of action consistent
13 with fairness to the parties; joinder of claims, parties and remedies is strongly encouraged.” *United*
14 *Mine Workers of Am. v. Gibbs*, 383 U.S. 715, 724 (1966). Rule 20(a) imposes two specific
15 requisites to the joinder of parties: (1) a right to relief must be asserted by, or against, each plaintiff
16 or defendant relating to or arising out of the same transaction or occurrence, and (2) some question
17 of law or fact common to all the parties must arise in the action. Fed. R. Civ. P. 20(a). Both of these
18 requirements must be satisfied in order to justify party joinder under Rule 20(a). *Id.* In situations of
19 misjoinder of parties, Rule 21 provides that “[o]n motion or on its own, the court may at any time,
20 on just terms, add or drop a party.”

21 1. Same Transaction, Occurrence, or Series of Transactions or Occurrences

22 “The Ninth Circuit has interpreted the phrase ‘same transaction, occurrence, or series of
23 transactions or occurrences’ to require a degree of factual commonality underlying the claims.”
24 *Bravado Int’l Group Merchandising Servs. v. Cha*, 2010 WL 2650432, at *4 (C.D. Cal. June 30,
25 2010) (citing *Coughlin v. Rogers*, 130 F.3d 1348, 1350 (9th Cir. 1997)). Typically, this means that a
26 party “must assert rights . . . that arise from related activities—a transaction or an occurrence or a
27 series thereof.” *Id.* (citation omitted). Recently, courts in this District – as well as several other
28

1 federal districts – have come to varying decisions about the propriety of joining multiple
2 defendants in BitTorrent infringement cases. *See MCGIP, LLC v. Does 1-149*, 2011 WL 3607666,
3 at *3 (N.D. Cal. Aug. 15, 2011) (listing a sample of recent decisions). This Court has carefully
4 reviewed such decisions and notes that they are highly dependent on the information the plaintiff
5 presented regarding the nature of the BitTorrent file-sharing protocol and the specificity of the
6 allegations regarding the Doe defendants’ alleged infringement of the protected work. Both of these
7 factors guide the Court’s joinder analysis in this matter as well.

8 Plaintiff asserts that because all of the Doe Defendants were part of the same swarm
9 downloading and distributing the same *Star Wars XXX: A Porn Parody* file during the same period
10 of time, the copyright claims arise from the same transaction and occurrence and raise common
11 issues of law and fact. While several courts have concluded that joinder is inappropriate under
12 similar circumstances, *see, e.g., Hard Drive Productions, Inc. v. Does 1–130*, 2011 WL 5573960
13 (N.D. Cal. Nov.16, 2011), the Court concludes that Plaintiff has at least made a prima facie showing
14 that the Doe Defendants are properly joined. *See Open Mind Solutions, Inc.*, 2011 WL 4715200 at
15 *7 (concluding that plaintiff made a preliminary showing that satisfied Rule 20 given the allegations
16 that the doe defendants were present in the same BitTorrent swarm and shared pieces of the same
17 seed file); *Braun v. Doe*, 2012 WL 3627640, at *3 (N.D. Cal. Aug. 21, 2012). Plaintiff has provided
18 enough specificity to make a preliminary determination that the Doe Defendants here were part of
19 the same swarm. Reviewing the IP logs attached to Mr. Strassmeir’s Declarations in each of the
20 cases, Defendants’ alleged infringing activity occurred over a period ranging from 63 to 193 hours.
21 *See Strassmeir Decls., Ex. A.* Plaintiff states that he tracked Defendant Doe One’s participation in
22 the swarm over the entire period of time alleged in each Complaint, limited the present cases to
23 individuals who participated in the same swarm at the exact same time, limited defendants to those
24 who likely accessed the Internet from within California, and alleged valid claims for contributory
25 infringement seeking to hold Defendants jointly and severally liable for the infringing conduct. Pl.’s
26 App. at 13.

27 Based on these allegations, Plaintiff’s claims against the Doe Defendants appear logically
28

1 related. Each putative Defendant is a possible source for Plaintiff’s copyrighted work, and may be
2 responsible for distributing the work to the other putative Defendants, who are also using the same
3 file-sharing protocol to copy the identical copyrighted material. *See Disparte v. Corporate Exec.*
4 *Bd.*, 223 F.R.D. 7, 10 (D.D.C. 2004) (to satisfy Rule 20(a)(2)(A) claims must be “logically related”
5 and this test is “flexible.”). While the Doe Defendants may be able to rebut these allegations later,
6 Plaintiff has sufficiently alleged that his claims against the Defendants potentially stem from the
7 same transaction or occurrence and are logically related. *See Arista Records LLC v. Does 1–19*, 551
8 F. Supp. 2d 1, 11 (D.D.C.) (“While the Court notes that the remedy for improper joinder is
9 severance and not dismissal, . . . the Court also finds that this inquiry is premature without first
10 knowing Defendants’ identities and the actual facts and circumstances associated with Defendants’
11 conduct.”); *Third Degree Films, Inc. v. Does 1-178*, 2012 WL 3763649, at *5 (N.D. Cal. Aug. 29,
12 2012) (same). Plaintiff has made a preliminary showing that these Defendants were present in the
13 same *Star Wars XXX: A Porn Parody* swarm on BitTorrent and shared pieces of the same seed file
14 containing *Star Wars XXX: A Porn Parody*.

15 2. Question of Law or Fact Common to All Defendants

16 Rule 20(a)(2)(B) requires Plaintiff’s claims against the putative Doe Defendants to contain a
17 common question of law or fact. Here, Plaintiff will have to establish against each Defendant the
18 same legal claims concerning the validity of the copyright in *Star Wars XXX: A Porn Parody* and the
19 infringement of the exclusive rights reserved to Plaintiff as copyright holder. Furthermore, Plaintiff
20 alleges that the Defendants utilized the same BitTorrent file-sharing protocol to illegally distribute
21 and download *Star Wars XXX: A Porn Parody* and, consequently, factual issues related to how
22 BitTorrent works and the methods used by Plaintiff to investigate, uncover, and collect evidence
23 about the infringing activity will be essentially identical for each Defendant. *See Call of the Wild*
24 *Movie, LLC v. Does 1-1062*, 770 F. Supp. 2d 332, 343 (D.D.C. 2011); *Third Degree Films*, 2012
25 WL 3763649, at *5. The Court recognizes that each putative defendant may later present different
26 factual and substantive legal defenses “but that does not defeat, at this stage of the proceedings, the
27 commonality in facts and legal claims that support joinder under Rule 20(a)(2)(B).” *Call of the Wild*
28

1 *Movie*, 770 F. Supp. 2d at 343.

2 3. Prejudice to Any Party or Needless Delay

3 Finally, the Court assesses whether joinder would prejudice the parties or result in needless
4 delay. Joinder in a single case of the putative defendants who allegedly infringed the same
5 copyrighted material promotes judicial efficiency and, in fact, is beneficial to the putative
6 defendants. *Id.* at 344; *London–Sire Records, Inc. v. Doe 1*, 542 F. Supp. 2d 153, 161 (D. Mass.
7 2008) (court consolidated separate Doe lawsuits for copyright infringement since the “cases involve
8 similar, even virtually identical, issues of law and fact: the alleged use of peer-to-peer software to
9 share copyrighted sound recordings and the discovery of defendants’ identities through the use of a
10 Rule 45 subpoena to their internet service provider. Consolidating the cases ensures administrative
11 efficiency for the Court, the plaintiffs, and the ISP, and allows the defendants to see the defenses, if
12 any, that other John Does have raised.”).

13 Here, Plaintiff is currently obtaining identifying information from ISPs so that it can properly
14 name and serve the Defendants. If the Court were to consider severance at this juncture, Plaintiff
15 would face significant obstacles in its efforts to protect its copyright from illegal file-sharers and this
16 would only needlessly delay the case. Plaintiff would be forced to file separate lawsuits against each
17 Doe Defendant, in which it would then move to issue separate subpoenas to ISPs for each
18 Defendant’s identifying information. Plaintiff would additionally be forced to pay the Court
19 separate filing fees in each of these cases, which would further limit its ability to protect its legal
20 rights. “This would certainly not be in the ‘interests of convenience and judicial economy,’ or
21 ‘secure a just, speedy, and inexpensive determination of the action.’” *Call of the Wild*, 770 F. Supp.
22 2d at 334 (citation omitted) (declining to sever defendants where parties joined promotes more
23 efficient case management and discovery and no party prejudiced by joinder).

24 Further, the Doe Defendants are currently identified only by their IP addresses and are not
25 named parties. Consequently, they are not required to respond to Plaintiff’s allegations or assert a
26 defense. Defendants may be able to demonstrate prejudice once Plaintiff proceeds with its case
27 against them, but they cannot demonstrate any harm that is occurring to them before that time. *Id.*

28

1 motions in this Court contesting the subpoena (including a motion to quash or modify the subpoena).
2 If that 30-day period lapses without Defendants contesting the subpoena, the ISP shall have 14 days
3 to produce the information responsive to the subpoena to Plaintiff.

4 Because no appearance by a person at a deposition is required by the subpoena, instead only
5 production of documents, records and the like is required, the witness and mileage fees required by
6 Rule 45(b)(1) of the Federal Rules of Civil Procedure do not apply and no such fees need be
7 tendered.

8 The subpoenaed entity shall preserve all subpoenaed information pending the ISP's
9 delivering such information to Plaintiff or the final resolution of a timely filed and granted motion to
10 quash the subpoena with respect to such information.

11 Any information disclosed to Plaintiff in response to a subpoena may be used by Plaintiff
12 solely for the purpose of protecting his rights under the Copyright Act, 17 U.S.C. §§ 101-1322.
13 Plaintiff shall serve each Doe Defendant with the summons, complaint, and other documents
14 required by Civil Local Rule 4-2 within 120 days of learning that Doe's identity.

15 Should Plaintiff engage in settlement negotiations with any Doe Defendant, he shall not
16 assert that that Doe is being sued in San Francisco, unless Plaintiff believes that Doe to be a resident
17 of this District or has a good faith belief, consistent with Federal Rule of Civil Procedure 11(b), that
18 it can otherwise establish personal jurisdiction over that Doe in this District.

19 **IT IS SO ORDERED.**
