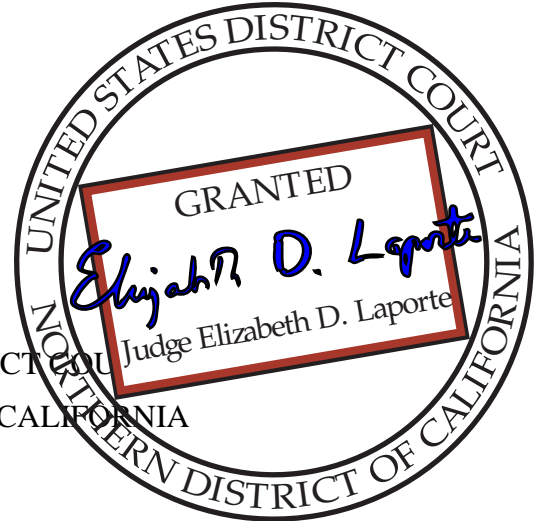

WHEREAS, Plaintiff Juan Cuevas (“Cuevas”) filed a Motion for an Order Requiring Defendant SkyWest Airlines, Inc. to Withdraw Objection to Production of Subpoenaed Documents (the “Motion”) against Defendant SkyWest Airlines, Inc. (“SkyWest”) on December 6, 2013, (Dkt. No. 75) and noticed the same for hearing before Judge Breyer on January 10, 2014;

1 WHEREAS, Cuevas filed an Amended Notice of Motion for an Order Requiring
2 Defendant SkyWest Airlines, Inc. to Withdraw Objection to Production of Subpoenaed
3 Documents on December 13, 2013, (Dkt. No. 85) noticing the hearing before Judge Laporte
4 on February 11, 2014;

5 WHEREAS, the parties do not believe that the time modification requested pursuant
6 to this stipulation would have any material effect on the schedule for this case;

7 WHEREAS, the parties are entering into this stipulation with the understanding and
8 expectation that the briefing schedule on Cuevas' Motion to Compel SkyWest to Produce or
9 Further Respond Concerning Documents Withheld from Production (Dkt. Nos. 78 and 84)
10 will remain unchanged; and

11 WHEREAS, the only other time modification in this case was a joint stipulation to
12 extend the time for responsive pleadings filed on January 18, 2013 (Dkt. No. 3) and a joint
13 stipulation to continue the hearing date for SkyWest's Motion for Summary Judgment filed
14 on December 17, 2013 (Dkt No. 86).

15 NOW, THEREFORE, the parties stipulate to the following:

16 1. SkyWest's opposition and supporting papers for the Motion will be filed and
17 served by no later than January 9, 2014; and

18 2. Cuevas' reply and any related papers for the Motion will be filed and served by
19 no later than January 24, 2014.
