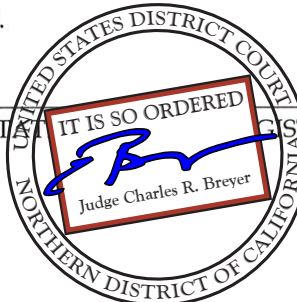
ORDER GRANTING APPLICATION

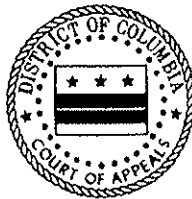
