4 proceedings for which his testimony is required in this Court;

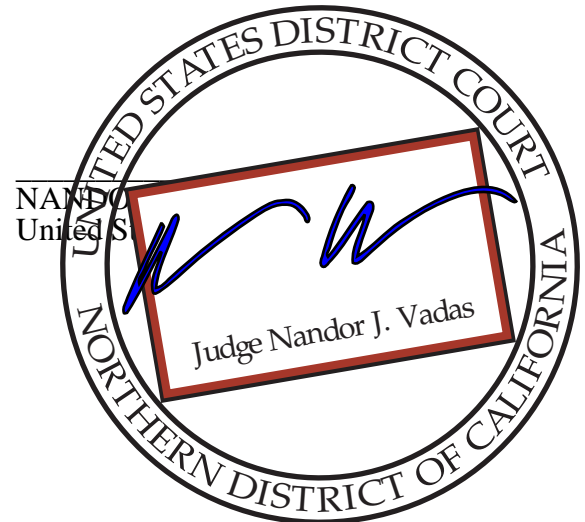
