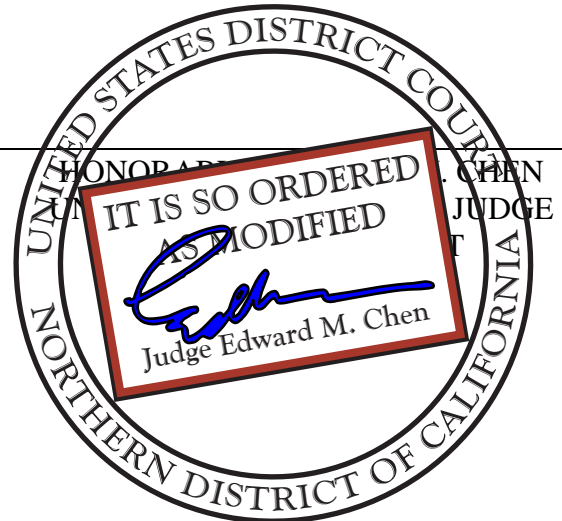
1 Having considered the Join Stipulation Continuing Deadline to Respond to Complaint and Setting
