 19 WHEREAS, on March 6, 2013, the Court issued an Order Granting Plaintiffs' Motion to
 20 Remand (Docket No. 28) (the "Order"), which, among other things, granted Plaintiffs
 21 PeopleBrowsr, Inc. and PeopleBrowsr, Pty Ltd.'s (collectively, "PeopleBrowsr") request for
 22 Defendant Twitter, Inc. ("Twitter") to pay PeopleBrowsr's reasonable costs and expenses, including
 23 attorneys' fees, incurred as a result of Twitter's removal of the above-captioned case;

24 WHEREAS, pursuant to the Order, PeopleBrowsr's brief detailing its costs and expenses,
 25 including attorneys' fees (the "Fees Brief"), was originally due on March 20, 2013;

26 WHEREAS, by stipulation and order of this Court dated March 21, 2013, the deadline for
 27 filing and service of the Fees Brief was extended to April 19, 2013, so that the parties could attempt to
 28 resolve the issue without the Court's intervention; and

1 WHEREAS, the parties desire more time to attempt to resolve the issue without the Court's
2 intervention;

3 **IT IS HEREBY STIPULATED AND AGREED that:**

4 Pursuant to Local Rule 6-2, PeopleBrowsr's time to file and serve the Fees Brief be extended
5 from April 19, 2013 to no later than May 17, 2013, and that Twitter's responsive pleading shall
6 remain due 14 days after the filing of the Fees Brief.
