22 14 day extension of time for Defendant to respond to Plaintiff's initial complaint.


23 Plaintiff served the initial Complaint on Defendant on December 14, 2012. Pursuant

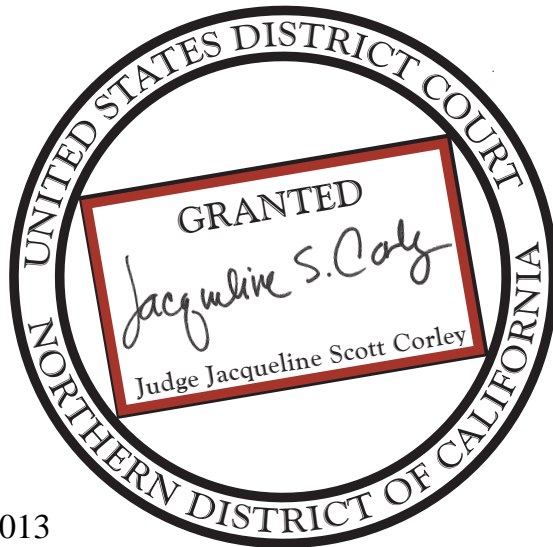
