**STIPULATION TO CONTINUE CASE  
 MANAGEMENT CONFERENCE AND  
 [PROPOSED] ORDER**

17 A case management conference is currently scheduled in this matter for Friday, March  
 18 14, 2014. This was scheduled to follow a second settlement conference with Magistrate Judge  
 19 Beeler that was originally set for March 4. That settlement conference has been put over to  
 20 March 18, 2014. If the matter does not settle on March 18, the parties have a large number of  
 21 depositions scheduled, including Mayor Quan on March 21 and other City officials and police
