1 The Court ORDERS as follows:

2 1. This Order supplements the Court's December 20, 2013 Order governing the  
3 discovery of electronic mail.

4 2. This Order applies to this litigation. The parties have requested a similar order in  
5 *Mentor Graphics Corp. v. EVE-USA, Inc. et. al.*, Case Nos. 3:10-CV- 954-MO, 3:12-CV-1500-  
6 MO, 3:13-CV-579-MO (D. Or.).

7 3. This Order may be modified for good cause.

8 4. On November 1, 2013, Parties filed a Stipulated Administrative Motion for Entry  
9 of Order for Discovery of Email (Dkt. No. 89) and Proposed Order (Dkt. No. 89-1) in which the  
10 Parties agreed to complete rolling productions of email by December 20, 2013.


11 5. The Court entered the Proposed Order on November 6, 2013 (Dkt. No. 97), setting  
12 December 20, 2013 as the date by when the parties shall complete rolling productions of email.

13 6. On December 19, 2013, Parties filed a Stipulation Extend the Email Discovery  
14 Deadline (Dkt. No. 116) and Proposed Order (Dkt. No. 116-1) in which the Parties agreed to  
15 complete rolling productions of email by January 10, 2014.

16 7. The parties have agreed to and have shown good cause to extend the deadline to  
17 complete rolling productions of email from January 10, 2014 to January 17, 2014.
