7 1. Plaintiff Synopsis, Inc. (“Synopsis”) and Defendant Mentor Graphics Corporation  
8 (“Mentor Graphics”) jointly moved the Court seeking leave:

- 9 a. for Mentor Graphics to serve amended invalidity contentions, as reflected in an
