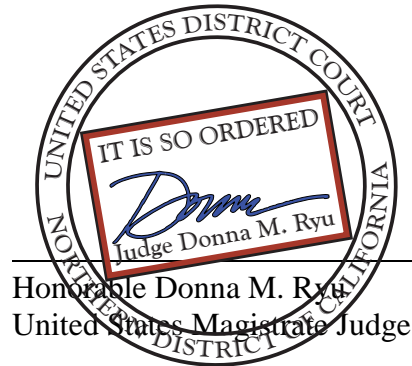
1 Having considered Synopsys' Administrative Motion to File Supplemental Submission
