1 **JOINT STIPULATION**

2 WHEREAS, on January 4, 2013, the Court issued an Order Setting Case Management
3 Conference and Requiring Joint Case Management Conference Statement (Dkt. 17), setting the Case
4 Management Conference for April 19, 2013, at 1:30 p.m. in Department 11;

5 WHEREAS, on April 1, 2013, the parties files a Joint Stipulation and [Proposed] Order
6 Continuing the Case Management Conference (Dkt. 53); on April 2, 2013, granted the Joint Stipulation
7 and Order Continuing the Case Management Conference (Dkt. 54) continuing the Case Management
8 Conference to June 14, 2013;

9 WHEREAS, on April 19, 2013, Plaintiff filed an Administrative Motion for Early Telephonic

17 IT IS HEREBY STIPULATED and agreed that, to ensure that the Case Management
18 Conference is as efficacious as possible, the parties request that the Court continue the May 10, 2013,
19 Case Management Conference so that it occurs after the parties' mediation; specifically, the parties
20 request a new Case Management Conference date of **May 24, 2013** following the scheduled mediation.
