GRANTING EXTENSION OF TIME TO
COMPLETE ALTERNATIVE DISPUTE
RESOLUTION; [~~PROPOSED~~] ORDER**

18 The deadline for completion of Alternative Dispute Resolution (“ADR”) in this case was
19 initially set to be completed on February 4, 2014. Dkts. 3, 35 (stipulation setting ADR deadline for
20 60 days after the court issued its claim construction order (the claim construction order issued on
21 December 3, 2013)). On January 15, counsel inquired with the Court whether this deadline could be
22 extended beyond February 4. On the same day, the Court issued a text only Order stating that that
23 the parties may file a stipulation proposing a new ADR deadline for the Court’s consideration. Dkt.
24 45.

25 Pursuant to Civil Local Rule 6-1(a), the parties stipulate, with the Court’s permission, to an
26 extension of the deadline for completion of ADR until March 31, 2014. This extension will allow
27 the parties enough time to gather, produce, and review damages related documents that will impact
28 negotiations in mediation.
