5 October 11, 2013 at 1:30 p.m.; the Defendants' answer was due on September 15, 2013.

6 4. In order to provide Defendants the necessary time to satisfy certain settlement
7 requirements, the Parties agree that the Case Management Conference and all related deadlines
8 shall be continued 60 days.

9 5. The Parties agree that the time within which Defendants shall answer or otherwise
10 move in response to Plaintiff's Complaint is extended through and includes October 31, 2013.
