4 WHEREAS, the Court has scheduled a case management conference for June 21, 2013, at
5 10:00 a.m. (Dkt. No. 13);

6 WHEREAS, Plaintiff filed an Amended Complaint on May 13, 2013 (Dkt. No. 16);

7 WHEREAS, Defendant anticipates filing a motion to dismiss the Amended Complaint on
8 June 17, 2013 and plan to set the motion to be heard at 10:00 a.m. on August 2, 2013; and

9 WHEREAS, the parties believe that the case management conference would be more
10 productive after the Court has had an opportunity to review or decide the motion to dismiss;

11 WHEREAS, the parties now seek to continue the case management conference until the
12 hearing date for the motion to dismiss, and to set forth a schedule for the briefing related to the
13 motion to dismiss;

14 NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED, subject to the
15 approval of the Court that:

- 16 1. Plaintiff’s response to the motion to dismiss shall be filed on or before July 12, 2013.
- 17 2. Defendants’ reply brief shall be filed on or before July 26, 2013.
- 18 3. Defendants’ motion to dismiss shall be heard by the Court at 10:00 a.m. on August 9,
19 2013, or at such time and date that is convenient for the Court.
- 20 4. The case management conference currently scheduled for June 21, 2013 shall be
21 continued to 10:00 a.m. on August²³, 2013, or to such time and date that is convenient
22 for the Court.
