1 **TIO DINERO SESSOMS**, inmate, CDCR # X1724067, a necessary and material witness
2 on his own behalf in proceedings in this case on Monday, February 13, 2017, is confined at
3 Sacramento County Main Jail, Sacramento County Sherriff's Department, 651 I Street,
4 Sacramento, CA 95814, in the custody of the Warden. In order to secure this inmate's attendance,
5 it is necessary that a Writ of Habeas Corpus ad Testificandum issue commanding the custodian to
6 produce the inmate before United States District Court Judge William Alsup at the United States
7 Courthouse, 450 Golden Gate, San Francisco, California 94102, in Courtroom No. 8, 19th Floor,
8 on February 13, 2017, at 7:00 a.m, and from day to day until completion of the proceedings, or as
9 ordered by the court.

10 **ACCORDINGLY, IT IS ORDERED that:**

11 1. A Writ of Habeas Corpus ad Testificandum issue, under the seal of this court,
12 commanding the custodian of the correctional facility to produce the inmate named above to
13 testify in United States District Court at the time and place above, and from day to day until
14 completion of court proceedings or as ordered by the court; and thereafter to return the inmate to
15 the above institution;

16 2. The custodian is ordered to notify the court of any change in custody of this
17 inmate and is ordered to provide the new custodian with a copy of this writ.

18 3. The Clerk of the Court is directed to serve a courtesy copy of this order and writ
19 of habeas corpus ad testificandum on the Sacramento County Main Jail, 651 I Street,
20 Sacramento, CA 95814 and the Sacramento County Sherriff's Department 711 G Street,
21 Sacramento, CA 95814, or to such other correctional facility in which plaintiff may be housed
22 during his trial.

23 **WRIT OF HABEAS CORPUS AD TESTIFICANDUM**

24 **To: The Warden**, Sacramento County Main Jail, Sacramento County Sherriff's Department,

1 **WE COMMAND** you to produce the inmate named above to testify before the United

4 proceedings, or as ordered by the court; and thereafter to return the inmate to the above
5 institution. **The inmate's legal property relevant to this case shall accompany the inmate to**
6 **court.**

7 **FURTHER**, you have been ordered to notify the court of any change in custody of the
8 inmate and have been ordered to provide the new custodian with a copy of this writ.
