1 **TO THE CLERK OF THE COURT:**

2 Pursuant to the Federal Rule of Civil Procedure 55(a), Plaintiff
3 PUBLIC.RESOURCE.ORG hereby requests entry of default against Defendant SHEET METAL
4 AND AIR CONDITIONING CONTRACTORS' NATIONAL ASSOCIATION, INC., on the
5 ground that Defendant has failed to respond to the Complaint for Declaratory and Injunctive
6 Relief (the "Complaint") within the time prescribed by the Federal Rules of Civil Procedure.

7 On March 14, 2013, counsel for Defendant signed and returned a Waiver of the Service of
8 Summons (the "Waiver"), which Public.Resource.Org subsequently filed with the Court. The
9 Waiver included the following statement: "I also understand that I, or the entity I represent, must
10 file and serve an answer or a motion under Rule 12 within 60 days from March 1, 2013, the date
11 when this request was sent." (Declaration of Corynne McSherry in Support of
12 Public.Resource.Org's Request for Clerk's Entry of Default ("McSherry Decl.") ¶¶ 2-4; Dkt. No.
13 11.) Under the Waiver, the Defendant's deadline to respond to the Complaint was April 30,
14 2013.

15 As of May 6, 2013, Defendant has not responded to the Complaint. (McSherry Decl. ¶ 5.)
16 Further, on May 3, 2013, Defendant advised counsel for Public.Resource.Org that "our client is
17 not intending on filing a responsive pleading." (McSherry Decl. ¶ 6 & Ex. 1.)

18 The accompanying Declaration of Corynne McSherry further sets forth the relevant facts.

19 For these reasons, Plaintiff respectfully requests that the Clerk enter default against
20 Defendant SHEET METAL AND AIR CONDITIONING CONTRACTORS' NATIONAL
21 ASSOCIATION, INC.
