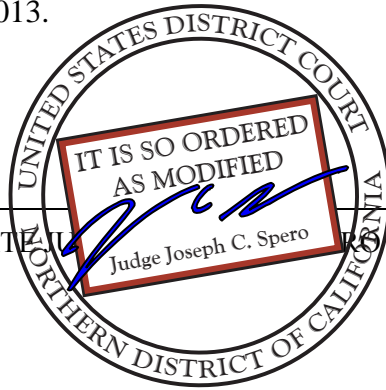
1 CASE MANAGEMENT ORDER
