7	made by the United States Department of Justice pursuant to 28 U.S.C. § 2679(d)(1) in response
8	to Plaintiff's amended complaint, Plaintiff may challenge such certification within the body of
9	her response to Defendants' new dispositive motion, in lieu of a separate pleading (such as a
10	motion to strike).
