 18 By this Stipulation and Proposed Order, the parties respectfully request that the time for
 19 defendant to answer, move or otherwise respond to the Complaint be extended, and the Initial Case
 20 Management Conference be adjourned, for the reasons stated below:

21 WHEREAS, the Complaint was filed on March 18, 2013; and

22 WHEREAS, the time for defendant to answer, move or otherwise respond to the Complaint
 23 expires on May 17, 2013 under a Stipulation which has been electronically filed with the Court [ECF
 24 No. 7]; and

25 WHEREAS, the parties are currently engaged in settlement discussions, have held one
 26 meeting to explore settlement and are continuing to pursue those discussions; and

27 WHEREAS, the parties wish to continue their settlement discussions over the next 30 days,
 28 rather than invest time and resources in litigation; and

1 WHEREAS, the parties have therefore agreed on an extension of the deadline for defendant to
2 answer, move or otherwise respond to the Complaint through June 17, 2013; and

3 WHEREAS, the Court has scheduled an Initial Case Management Conference for June 27,
4 2013* @ 10:00 a.m.; and

5 WHEREAS, the parties seek the extension and adjournment to allow them to focus on the
6 settlement discussions;

7 NOW THEREFORE, the parties hereby agree and stipulate to an extension of the date by
8 which defendant must answer, move or otherwise respond to the Complaint through and including
9 June 17, 2013, and request that the Court adjourn the Initial Case Management Conference to a date
10 at least 35 days after June 17, 2013.
