14 On October 18, 2013, the Clerk mailed Petitioner a notice that he had neither paid  
15 the filing fee nor filed a complete application to proceed in forma pauperis. The notice  
16 was mailed to Petitioner at the address he provided to the Court, but on November 12,  
17 2013, it was returned by the postal service as undeliverable with a notation that Plaintiff  
18 could was not located at that address. Local Rule 3.11 requires Petitioner to notify the  
19 Court of any change in his address, and that his failure to do so within sixty days of a  
20 change of address will result in the dismissal of the action. Petitioner has not provided  
21 the Court with a correct address within sixty days of the date the mail was returned as  
22 undeliverable. Accordingly, this case is DISMISSED without prejudice. The motion to  
23 dismiss (dkt. 14) is DENIED as moot.

24 The Clerk shall enter judgment and close the file.
