1 **STIPULATION**

2 The parties hereby stipulate and agree, subject to approval of the Court,
3 as follows with regard to the currently scheduled Further Case Management
4 Conference on January 22, 2015 in the above-captioned matter:

5 WHEREAS, the parties appeared for a Further Case Management
6 Conference on November 13, 2013.

7 WHEREAS, on April 1, 2014 the Court issued an Order referring the
8 case to Magistrate Judge James for settlement discussions. *See* ECF 97.

9 WHEREAS, on May 2, 2014 the parties participated in a settlement
10 conference before Magistrate Judge James. Per the Court's Minute Entry, the
11 parties were to return for a further settlement conference. *See* ECF 98.

12 WHEREAS, on June 5, 2014, the parties attended a Further Case
13 Management Conference and the parties were directed to schedule a further
14 settlement conference with Magistrate Judge James to be completed by
15 December 12, 2014. A Further Case Management Conference was set for
16 January 8, 2015 following completion of the further settlement conference.
17 *See* ECF 102.

18 WHEREAS, Magistrate Judge James issued an order scheduling the
19 further settlement conference for December 10, 2014. *See* ECF 104.

20 WHEREAS, on December 4, 2014, due to Magistrate Judge James'
21 unexpected unavailability, the Court issued a Clerk's Notice advising that the
22 further settlement conference scheduled for December 10, 2014 was vacated.
23 *See* ECF 117.

24 WHEREAS, on December 19, 2014, the Court issued a Clerk's Notice
25 re-scheduling the further settlement conference for January 26, 2015. *See* ECF
26 121.

1 WHEREAS, on December 2, 2014, the Court issued a Clerk's Notice
2 resetting the Further Case Management Conference to January 22, 2015.

3 WHEREAS, due to the calendar availability of Magistrate Judge James
4 (to host the further settlement conference) and the availability of the parties,
5 the further settlement conference is not scheduled to occur until a date shortly
6 after the Further Case Management Conference on January 22, 2015.

7 WHEREAS, the parties believe it would be beneficial to complete the
8 further settlement conference before appearing for the Further Case
9 Management Conference.

10 Therefore, the parties stipulate and agree and respectfully request the
11 Court to issue an order continuing the Further Case Management Conference
12 to a date convenient for the Court after January 26, 2015.

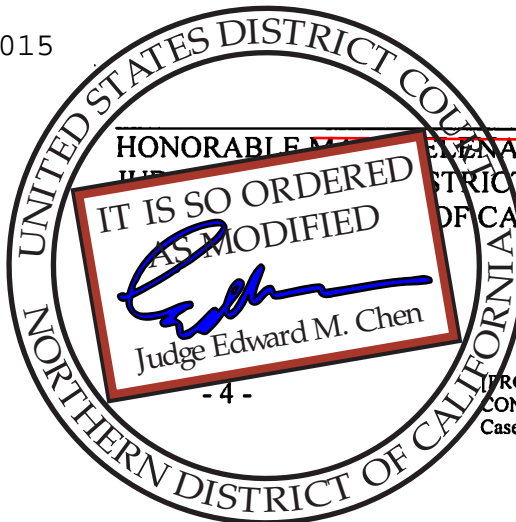
