1 Pursuant to Local Rules 6-2 and 7-12, it is hereby stipulated by and between
2 Plaintiffs Ohio Public Employees Retirement System, State Teachers Retirement System
3 of Ohio, Ohio Bureau of Workers Compensation, and Highway Patrol Retirement System
4 (collectively “Plaintiffs” or “OPERS”) and Defendant McKesson Corporation
5 (“McKesson”), through their respective attorneys, as follows:

6 The initial case management conference in this matter is currently scheduled for
7 August 2, 2013 at 2:30 p.m. The parties’ deadline to meet and confer pursuant to Federal
8 Rule of Civil Procedure 26(f), to file ADR certifications, and to file either a Stipulation to
9 ADR Process or Notice of Need for ADR Teleconference, is currently set for July 12,
10 2013. The parties’ 26(f) report, initial disclosures, and joint case management statement
11 are currently due on July 25, 2013.

12 This action was initially assigned to Magistrate Judge Elena E. James, who had set
13 a case management conference for August 1, 2013 at 10:00 a.m. When this case was
14 reassigned to this Court, the case management conference was rescheduled to August 2,
15 2013 at 2:30 p.m. The deadline to reschedule the initial case management conference is
16 July 23, 2013.

17 The parties respectfully request that the case management conference be continued
18 to August 9, 2013 at 2:30 p.m. The parties further request that the deadline to meet and
19 confer pursuant to Federal Rule of Civil Procedure 26(f), to file ADR certifications, and
20 to file either a Stipulation to ADR Process or Notice of Need for ADR Teleconference be
21 continued until 21 days prior to the case management conference, and that deadline for
22 the parties’ 26(f) report, initial disclosures, and joint case management statement be
23 continued until seven days prior to the conference.
