Any request to reschedule the above date should be made in writing, and by 8 stipulation, if possible, not less than ten days before the conference date. Good 9 cause must be shown. 10 At the Case Management Conference the parties should be prepared to address and 11 e. 12 resolve the following: setting the date and the estimated length of the trial; setting 13 the date for discovery cutoff; setting the date to designate experts and other 14 witnesses; and setting the date for the pretrial conference. 15 2. Notice to Unrepresented (Pro Se) Parties in Non-Prisoner Cases 16 Parties representing themselves should visit the link titled "Representing Yourself" a. 17 on the Court's homepage, www.cand.uscourts.gov. The link discusses the Court's 18 19 "Legal Help Center" for unrepresented parties, run by the Court's Federal Pro Bono 20 Project. The Legal Help Center can be reached at 415-782-9000 ext. 8657 and is 21 located on the 15th Floor, Room 2796, of the courthouse at 450 Golden Gate 22 Avenue in San Francisco. 23 If you are representing yourself and you have not been granted leave to proceed *in* b. 24 forma pauperis (IFP) by the Court, you must comply with the service requirements of 25 Rule 4 of the Federal Rules of Civil Procedure, as set forth below. Failure to follow the 26 procedures may result, under Rule 4(m), in dismissal of your case: 27 28

(i) It is your responsibility to obtain a valid summons from the clerk and to effect 1 service of the summons and complaint on all defendants in accordance with 2 Rule 4 of the Federal Rules of Civil Procedure. If you have named the United 3 States government, a federal agency, a federal official or a federal employee as 4 5 a defendant, you must comply with the special requirements of Rule 4(i). 6 (ii) Service may be effected by any person who is not a party and who is at least 18 7 years of age, which means that you, as a party, may not effect service. If 8 service of the summons and complaint is not made upon a defendant within 9 120 days after the filing of the complaint, your action will, under Rule 4(m), be 10 dismissed as to that defendant. 11 (iii) Within 125 days after the filing of the complaint, you must file proof of service 12 indicating which defendants were served within the 120 days allowed under 13 Rule 4(m) and showing, in accordance with Rule 4(i), how each of those 14 15 defendants was served (for example, by attaching appropriate certificates of 16 service). You must also show cause why a defendant not served within the 120 17 days allowed under Rule 4(m) should not be dismissed without prejudice. 18 (iv) Failure to do these things within the designated time will result in the dismissal 19 of your case under Rule 4(m) and Rule 41(b). 20 Dated: July 24, 2013 21 De 22 WILLIAM H.
