1 The Court, having considered the Parties' Joint Stipulation to Permit Defendant
2 Aaron Yashouafar to File a Responsive Pleading by Submitting a Joinder to the
3 Pending Motion to Dismiss, and good cause appearing, hereby orders as follows:

- 5 1. Defendant Yashouafar may appear in the case now and file a responsive
6 pleading by filing a joinder to the Pending MTD;
- 7 2. If the Courts elects to hold oral argument on the Pending MTD, the
8 Receiver's counsel shall be allowed to present argument on issues unique
9 to Yashouafar; and
- 10 3. If the Court elects not hold oral argument on the Pending MTD, the
11 Receiver may file a supplemental brief of five pages or fewer addressing
12 issues unique to Yashouafar to be filed within five business days of entry
13 of an order vacating the hearing date.
