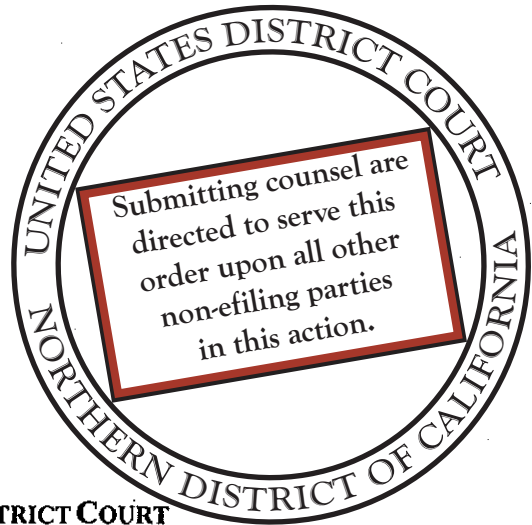

27 motion to reopen this action by May 1, 2014, the dismissal shall be deemed to be **with prejudice**.



2 referenced-above shall bear its own attorneys' fees and costs.


