 31 HOMEWARD RESIDENTIAL, INC. filed on July 8, 2013 (Docket No. 17) shall be amended to

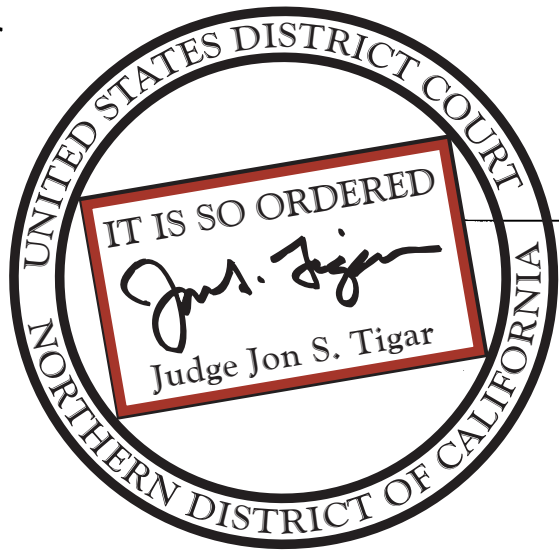
1 substitute the "ESTATE OF THOMAS SCOTT PATTILLO" for fictitious cross-defendant
