ORDER VACATING MOTION HEARING

Before the Court is Defendants' Motion for Summary Judgment. Dkt. No. 42. Pursuant to Federal Rule of Civil Procedure 78(b) and Civil Local Rule 7-1(b), the Court finds that the matter is suitable for disposition without oral argument.
