1 **STIPULATION AND REQUEST**

2 Plaintiff Christopher Surbey ("Plaintiff") and Defendants Pacific Gas and Electric  
3 Company and PG&E Corporation ("Defendants") (collectively referred to as the "Parties")  
4 through their respective counsel hereby stipulate as follows:

5 WHEREAS on November 14, 2013, the Court issued an Order referring the Parties to a  
6 court-provided mediation pursuant to stipulation of the Parties;

7 WHEREAS on December 9, 2013, the Court appointed Mark LeHocky as the mediator;

8 WHEREAS on February 3, 2014, the Court granted the Parties' stipulated request to  
9 extend the deadline to conduct mediation from February 12, 2014 to May 7, 2014;

10 WHEREAS the Parties subsequently scheduled a mediation with Mr. LeHocky for May 7,  
11 2014;

12 WHEREAS on March 20, 2014, Mr. LeHocky withdrew as mediator in light of a  
13 potential conflict of interest;

14 WHEREAS on March 21, 2014, the Court appointed G. Scott Emblidge as the new  
15 mediator; and

16 WHEREAS on April 4, 2014, the Parties participated in a pre-mediation conference call  
17 with Mr. Emblidge and agreed upon a new mediation date of June 20, 2014, in order to give the  
18 Parties sufficient time to conduct limited discovery prior to the mediation;

19 NOW, THEREFORE, IT IS HEREBY STIPULATED AND REQUESTED by and  
20 between the Parties through their respective attorneys of record that the deadline to conduct  
21 mediation be extended from May 7, 2014 to June 20, 2014.
