1 TO THE COURT, ALL PARTIES, AND THEIR COUNSEL OF RECORD:

2 Plaintiffs Stephanie Allen and Rosetta Stone Ltd. ("Plaintiffs") and defendant OE Services,
3 LLC ("Defendant"), by and through their respective counsel of record, hereby agree and stipulate
4 follows:

5 1. On May 31, 2013, Defendant removed this lawsuit from the Superior Court.
6 (Docket No. 1.)

7 2. As shown in the parties' November 12, 2013 Joint Case Management Statement,
8 there are two related cases pending: (1) *Wilson et al. v. OE Services, LLC, et al.*, San Francisco
9 Superior Court, Case No. CGC-13-529395; and (2) *OE Services, LLC v. Wilson et al.*, Circuit
10 Court of the Eleventh Judicial Circuit in and for Miami-Dade County, Case No. 13-04474 CA-15.
11 (Docket No. 33.)

12 3. On March 11, 2014, parties notified the Court that they had reached a tentative
13 global resolution of their disputes and were working on a settlement agreement that would dispose
14 of this lawsuit. (Docket No. 39.)

15 4. That same day the Court issued a Standby Order of Dismissal, which set May 5,
16 2014 as the deadline by which the parties were to submit a stipulation of dismissal. (Docket
17 No. 40.) Absent a stipulated dismissal, the parties were to appear for an Order to Show Cause
18 hearing on May 8, 2014. (*Id.*)

19 5. The parties hereby report that they have reached a global resolution of their
20 disputes. A settlement agreement has been drafted, agreed upon, and is currently in the process of
21 being signed by all parties and their respective counsel.

22 6. The parties are unable to submit a stipulation of dismissal by today's May 5, 2014
23 deadline as the settlement agreement still requires three additional signatures (out of the seven
24 total) to effectuate the agreement. The parties anticipate being able to submit a stipulation of
25 dismissal in the near future.

26 7. Consequently, for the mutual benefit of the parties and for purposes of judicial
27 economy, the parties respectfully request that the deadline to submit a stipulation of dismissal and

1 the Order to Show Cause hearing be continued to allow the parties additional time to effectuate the
2 agreement before seeking a stipulated dismissal.

3 NOW, THEREFORE, IT IS AGREED AS FOLLOWS:

4 1. The parties' deadline to submit to a stipulation of dismissal should be continued
5 from May 5, 2014 to June 2, 2014, and the Order to Show Cause hearing should be continued
6 from May 8, 2014 to June 5, 2014.
