 24 participate in an evidentiary hearing in the United States District Court, until

25 2. The custodian is ordered to notify the Court of any change in custody of
 26 this inmate, and is ordered to provide the new custodian with a copy of this writ;

1 3. The U.S. Marshals Service shall transport the inmate named above to
2 the Northern District of California forthwith so that he may so he may participate
3 in an evidentiary hearing in the United States District Court until completion of
4 court proceedings or as ordered by the Court; and

5 4. The Clerk of the Court is directed to serve a courtesy copy of this order
6 and writ of habeas corpus ad testificandum on Federal Correctional Institution
7 Safford – Post Office Box 820, Safford, Arizona, 85548.
